

## FAQs regarding our name change

Beginning December 31, our name became Land o' Sunshine Camp Cedarbrook, Inc. Our Association's name changed to Association of Cedarbrook Camps. This FAQ sheet is designed to help answer questions regarding this change.

**Q** Why change the name we have had for 25 years?

**A** Our previous name was trademarked to our licensing organization. We have "rented" the name by paying them a fee to use this trademark. We have decided to stop renting the name and own our own name. This was a unanimous decision by our Board of Directors.

**Q** When will this take place?

**A** As of December 31 we stopped using our previous name. We have already begun using Land o' Sunshine Camp Cedarbrook as our new name.

**Q** Is this a permanent change?

**A** Yes, we have been considering and praying about this for some time and believe that for us to continue to honor the Lord in His ministry at our camp, a name change is essential. We have not made this decision lightly but have diligently prayed and sought the Lord on this matter.

**Q** Will this change anything else?

**A** No, nothing else will change. The philosophy will stay the same. The program will stay the same. The leaders will stay the same. The rental sites will not change. Our goals of reaching boys and girls for Jesus Christ will stay the same.

**Q** Will the campsites change?

**A** No, we will use the same rental campsites. Only the name changes.

**Q** Will the registration process change?

**A** No, the process is the same, just use the new name on checks sent to the registrar.

**Q** Will this affect the fees?

**A** No, the fees will only change as rental costs and prices increase.

**Q** Will there be changes to the program?

**A** The program will stay the same. There will be a new theme and an outcome each summer. We will sing the same silly songs and have Bible Exploration with cabin groups as well as Morning Watch. Sunday worship, activities and campfires will all be the same.

**Q** How will contributions be handled?

**A** Your gifts will go to support the same program and designations as before. The only difference is that checks need to be made out to Land o' Sunshine Camp Cedarbrook or LOSCC.

**Q** Are you still a not-for-profit camp?

**A** Yes. We have filed a name change with the State of Florida and still remain as a 501(c)3 not-for-profit institution. Your tax deduction remains the same. Just change the name when you file your tax return for any contributions made after December 31, 2008.

**Q** Will the website change?

**A** Yes, our new address is [www.campcedarbrookFL.org](http://www.campcedarbrookFL.org). The website of our association is [www.cedarbrookcamps.com](http://www.cedarbrookcamps.com) which has a link to our camp.

**Q** If we have added Land o' Sunshine to our will, trust or any other giving vehicle, do we need to change the name?

**A** It would be in your best interest, if you wish to continue to support this camping ministry, to change the camp name on any wills, trusts, endowments, insurance policies, etc. We would welcome your continued partnership in reaching and discipling campers for Christ under the new name for our ministry, Land o' Sunshine Camp Cedarbrook, Inc.

**Q** Will you still be responsible to some organization?

**A** For sixteen years all the camps have been led by an Association. It conducts training, support and evaluation. That will continue. Only the name has changed to Association of Cedarbrook Camps.

**Q** Will you still be accredited by ACA?

**A** Yes, most definitely. Standards have not changed. All Cedarbrook camps will be accredited by the American Camp Association.

**Q** Can churches using the weekday club program with which we were formerly associated still attend camp?

**A** All children are welcomed, especially from those churches. The philosophy and statement of faith of both organizations is still the same.
